### 9.3 Approval of the Rental Proposal.

WHEREAS the Municipality of Bryson wishes to acquire a 2004 Freightliner M2 fire truck (72,000 km) from City View Specialty Vehicles located in Mississauga, Ontario, at a price of \$165,000 plus taxes;

WHEREAS the Municipality intends to finance this acquisition through a finance lease agreement with Mitsubishi HC Capital Canada, located at 500 Saint-Martin Boulevard, Laval, Quebec, H7M 3Y2;

WHEREAS the terms of the financing include a down payment of \$17,246.25 (including the first rent of \$15,000 plus taxes), a term of 46 months, an interest rate of 7.25%, a one-time administration fee of \$750 plus taxes, and a purchase option of \$10 at the end of the term;

WHEREAS the proposal is valid until June 10, 2025 and certain conditions must be met, including supplier approval, a virtual inspection, the provision of void cheques, proof of insurance (\$2,000,000 in liability and property damage), as well as a refund of the initial deposit of \$10,000 paid by the Municipality;
